

ROTORUA GIRLS' HIGH SCHOOL (153)

ENROLMENT SCHEME

The guidelines for the development and operation of enrolment schemes are issued under section 72(1) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

The Rotorua Girls' High School enrolment zone boundary matches that of the Rotorua District Council area.

Starting from 2447 Broadlands Road, the boundary travels north, along the east bank of the Waikato River, continuing along the edge of Lake Ohakuri, to Lake Atiamuri. From Lake Atiamuri the boundary travels north-east along the Whangapoa Stream, and Tahunaatara Stream, to State Highway 30 (behind 16 Ohakuri Road - this address included in the zone).

From here the boundary travels north-east, along State Highway 30, including odd-numbered addresses only, to where Tahunaatara Stream crosses the highway. From here the boundary pivots north, following the east bank of the Tahunaatara Stream to the fork with Rahopakapaka Stream and Pokaitu Stream.

From this fork the boundary continues north along the east bank of the Rahopakapaka Stream to the fork with Matahana Stream.

From this fork the boundary travels in a straight line, along the top of the Horohoro Forest Bluffs, to 355 Kearoa Road (this address included in the zone), then north-west in a straight line to the south-west corner of 739 South Road (this address included in the zone).

From here the boundary crosses South Road and travels west, along the northern boundary of the Horohoro Forest to the "dead end" of Galaxy Road, then pivots north, to 563 Arahiwi Road (this address included in the zone).

From 563 Arahiwi Road, the boundary crosses the railway line and Arahiwi Road, to include 550 Arahiwi Road, then continues north-east along the boundary of the Paterere Scenic Reserve to 378 Cecil Road (this address included in the zone).

From 378 Cecil Road the boundary continues north-east behind (and including) addresses on Amoores Road and Barker Road, to 1599 State Highway 5 (this address included in the zone). From here the boundary crosses State Highway 5, continuing north-east to the TECT Park (excluded from the zone).

From the TECT Park, the boundary travels east, following the Ohaupara Stream, crossing State Highway 36, and continuing along the Ohaupara Stream to the Mangorewa River. The boundary travels east along the Mangorewa River to the northern boundary of 899 Kapukapu Road (this address is included in the zone).

From 899 Kapukapu Road the boundary travels directly east to the Kaituna River, then onward, to the southern end of the Pokopoko Scenic Reserve (excluded from the zone) on State Highway 33. The boundary continues further east, south of (and excluding) Roydon Downs Scenic Reserve, to 1815 Maniatutu Road (this address is excluded from the zone). The boundary crosses Maniatutu Road, to the Pongakawa Stream and on to Rotoehu Road, just north of the Carrie Gibbons Scenic Reserve.

From here the boundary travels south along Rotoehu Road to the intersection with Pongakawa Valley Road, then proceeds along Pongakawa Valley Road to 413 Pongakawa Valley Road (this address is included in the zone).

From 413 Pongakawa Valley Road the boundary proceeds directly east, to where the Morepara River crosses Manawahe Road.

From here the boundary travels south to 838 Matahi Road, crossing the road to capture 839 Matahi Road, and then proceeds south-west behind other addresses on Matahi Road to the intersection with State Highway 30.

From this intersection the boundary travels directly south to 1898 Ngamoutu Road (this address is excluded from the zone) and continues south to 1129 Northern Boundary Road.

From 1129 Northern Boundary Road the boundary travels south, goes around the township of Kaingaroa, and travels to the intersection of Goudies Road and State Highway 38.

From the intersection of Goudies Road and State Highway 38, the boundary travels south along the centre of Goudies Road to the intersection of Goudies Road and Waimahunga Road.

From this intersection the boundary travels north-west to the rear of 144 Plateau Road (this address is included in the zone), then pivots south-west behind, and including, addresses on Waikoroa Road, and Allen Road, and then on to 2447 Broadlands Road.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Special Programmes

Rotorua Girls' High School does not operate a special programme.

Applications for enrolments will be processed in the following order of priority:

- **First priority** must be given to students who have been accepted for enrolment in the above special programme(s) run by the school and approved by the Secretary for Education. As Rotorua Girls' High School does not operate a special programme, this priority does not apply.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.

- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Schedule 20 (2) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Proof of residence within the home zone may be required.
