# Blenheim School (2811) Enrolment Scheme

Effective from Day Month Year

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

## **Home Zone**

All students who live within the home zone described below shall be eligible to enrol at the school.

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the intersection of Boyce Street and Brook Street, the home zone follows:

- East along Boyce Street until High Street
- East along High Street until Lee Street
- South along Lee Street until Charles Street
  - o Including Lee Street between Charles Street and Arthur Street
- East along Charles Street until Percy Street
  - o Including Beaver Road between Charles Street and Arthur Street
- South along Percy Street until Arthur Street
- East along Arthur Street until Richmond Street
- South along Richmond Street until George Street
- East along George Street until Henry Street
- South along Henry Street until Maxwell Road
- North-east along Maxwell Road until Seymour Street
- South-east along Seymour Street until Francis Street
- East along Francis Street until Redwood Street
  - Including Scott Street between Francis Street and Nosworthy Street
- North along Redwood Street until Mcartney Street
  - Including Redwood Street between Francis Street and Nosworthy Street
- East along Mcartney Street until the end of Mcartney Street
  - Including Houldsworth Street between Mcartney Street and Park View Lane,
  - And including Park View Lane
- From the eastern end of Mcartney Street (by the railway line) jumps east to the corner of South Street and Sutherland Terrace
- North along Sutherland Terrace until Main Street
  - o Including Kinross Street between Sutherland Terrace and Stuart Street
- East along Main Street until Stuart Street
- North along the western side of Stuart Street until Park Terrace
- West along Park Terrace until Opawa Street
- North along Opawa Street until the end of Opawa Street
- From the northern end of Opawa Street jumps north to the end of Snowden Crescent

- West along Snowden Crescent until Dillons Point Road
- East along Dillons Point Road up to and including number 68 Dillons Point Road
- From number 68 Dillons Point Road travels west back along Dillons Point Road until Grove Road
  - Including Meehan Street,
  - o Including Lane Street,
  - And including Walnut Lane
- North along Grove Road until Warwick Street
- West along Warwick Street until Pitchill Street
- West along Pitchill Street until Hutcheson Street
  - o Including Pitchill Street to the west of Hutcheson Street
- South along Hutcheson Street until Parker Street
- West along Parker Street until Mclauchlan Street
- South along Mclauchlan Street until Nelson Street
- East along Nelson Street until Beaver Road
  - o Including Mill Stream Lane
- South along Beaver Road until High Street
  - Including Alfred Street to the west of Beaver Street
- West along High Street until Lee Street

#### Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

# **Out of Zone Enrolments**

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

First Priority This priority is not applicable at this school because the school

does not run a special programme approved by the Secretary

for Education.

**Second Priority** will be given to applicants who are siblings of current

students.

**Third Priority** will be given to applicants who are siblings of former students.

**Fourth Priority** will be given to any applicant who is a child of a former student

of the school.

**<u>Fifth Priority</u>** will be given to any applicant who is either a child of an

employee of the board of the school or a child of a member of

the board of the school.

## **Sixth Priority** will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
