

Christchurch South Karamata Intermediate School (3318)

Proposed Enrolment Scheme

Home Zone

All students who live within the home zone described below (Area A on the attached map) shall be eligible to enrol at the school.

Starting from the intersection of Rose Street and Lyttelton Street

- North along Lyttelton Street to Frankleigh Street
- North East along the south side only of Frankleigh Street to Barrington Street
- North West along the north east side only of Barrington Street to Brougham Street
- North West along both sides of Barrington Street to Lincoln Road
- North East along the south east side only of Lincoln Road to Moorhouse Avenue
- East along Moorhouse Avenue to Colombo Street
- South along the west side only of Colombo Street to the Colombo Street Bridge over the Ōpāwaho (Heathcote) River
- East along the south bank of the Ōpāwaho River to the Malcolm Avenue bridge
- East along the Malcolm Avenue bridge to Waimea Terrace
- North along Waimea Terrace to Martin Avenue
- East along Martin Avenue to Birdwood Avenue
- South along Birdwood Avenue to Eastern Terrace
 - Including Piper Lane and Karen Lane
- East along the south side only of Eastern Terrace to the Bowenvale Avenue Bridge
- South along Bowenvale Avenue to Wedgewood Avenue
 - Including the entirety of Bowenvale Avenue and all addresses accessed from cul-de-sac roads off Bowenvale Avenue
- West along Wedgewood Avenue to Landsdowne Terrace
- North along Landsdowne Terrace to Gunns Crescent
 - Including the entirety of Landsdowne Terrace and all addresses accessed from cul-de-sac roads off Landsdowne Terrace
- West along Gunns Crescent to Holliss Avenue
- From the Gunns Crescent / Holliss Avenue intersection due West to Rossmore Terrace
 - Including the entirety of Holliss Avenue and all addresses accessed from cul-de-sac roads off Holliss Avenue
- North on Rossmore Terrace to Centaurus Road
 - Including the entirety of Rossmore Terrace and all addresses accessed from cul-de-sac roads off Rossmore Terrace
- West along Centaurus Road to Merlewood Avenue
 - Including St Vincent Terrace
- South along Merlewood Avenue to Cracroft Terrace
- West along Cracroft Terrace to Dyers Pass Road
 - Including all addresses on Cracroft Terrace and Sulby Road
- North along Dyers Pass Road to Cashmere Road
 - Including all addresses on Rhodesvale Terrace
- West along Cashmere Road to Purau Terrace
 - Including all addresses on Purau Terrace
- North across the Ōpāwaho River to Ashgrove Terrace
- South West along Ashgrove Terrace to Cashmere View Street
 - Including Ashgrove Terrace between Cashmere View Street and Ferniehurst Street
- North West along Cashmere View Street to Rose Street
- South West along Rose Street to Lyttelton Street
 - Including Marley View Street

Also included are addresses;

- From the Cashmere Road / Purau Terrace intersection, West along the south side only of Cashmere Road to Hendersons Road,
- Including all addresses on Brookford Place, Cashmere Road addresses from Hendersons Road to 435 Cashmere Road, and all addresses accessed from Happy Home Road.
- Including addresses on Opihi Street, Hurunui Street, Waipara Street, Waiau Street, and Pahau Place

Also included are all addresses which are both a) accessed via Penruddock Rise and b) west of Worsleys Road (the “Westmorland” area)

Also included are all addresses accessed via Worsleys Road (including the “Cashmere Estates” subdivision).

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Additional Entitlement to Enrol

This provision may be approved under Section 75 1 (a) of the Education and Training Act 2020.

For families of currently enrolled students whose addresses become out of zone as a result of the amendment to this Enrolment Scheme.

Section 75 of the Education and Training Act 2020 states that;

“the Secretary may authorise an enrolment scheme to permit a student to enrol at the school as if the student lived in the home zone of the school if, -

(a) in the case of an existing enrolment scheme whose home zone is amended, —

- (i) the student lives outside the amended home zone; and
- (ii) the student has a sibling who is enrolled at the school at the time that the amendment is implemented; and
- (iii) the sibling, at the time that the amendment is implemented, lives inside the home zone as it was before the amendment; and
- (iv) the student, at the time of enrolment, lives inside the home zone as it was before the amendment:

If applying for enrolment under this part of the Enrolment Scheme, the sibling’s name and evidence of a sibling relationship may be required by the school.

[Section 75](#) of the Education and Training Act 2020 sets out the definition of a “sibling” for these purposes.

The school will maintain a list of students enrolled at the time of the implementation of the enrolment scheme change by the Board in order to enable determination of eligibility to enrol under this provision.

Note: That this is a very tightly defined definition. It would not apply to:

1. Children who move into the withdrawal area after the implementation of the enrolment scheme boundary amendment; or
2. Children of families/whānau who move out of the old zone after the implementation of the enrolment scheme boundary amendment.

Out of Zone Enrolments

Applications for enrolments will be processed in the order of priority specified in the [Education and Training Act 2020](#).

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of address or sibling relationship.

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.
