# Clyde School (3725) Enrolment Scheme

Effective from 01 February 2023

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

## **Home Zone**

All students who live within the home zone described below shall be eligible to enrol at the school.

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the western end of Fraser Dam Road, the home zone follows:

- East along Fraser Dam Road until its intersection with Blackman Road and Hawley Road
- North along Hawley Road until its intersection with McIntosh Road and Strode Road
- East and then north along Strode Road until Laing Road
- · East along Laing Road until Earnscleugh Road
- South along Earnscleugh Road until McPherson Road
- East along McPherson Road until the end of McPherson Road
- From the end of McPherson Road jumps north-east across the Clutha River to the intersection of Airport Road and Clyde-Alexandra Road (SH 8)
- North-west along the western side of Airport Road until Coates Road
  - Including Ruru Lane
- North-east along the northern side of Coates Road until its intersection with Dunstan Road
- North-east along Coates Road until Airport Road (by number 166 Coates Road)
- South-east then north along Airport Road until Springvale Road
- East along Springvale Road until Golden Road
  - o Including Thyme Fields Road and all the side streets off it
- North along Golden Road until Nelsen Ridge Road
  - Including all side streets off Golden Road between Springvale Road and Nelsen Ridge Road
- East and then north along Nelsen Ridge Road until Swamp Lane
  - Including all the side streets off Nelsen Ridge Road between Golden Road and Swamp Lane
- North Along Nelsen Ridge Road until the end of Nelsen Ridge Road
  - o Including Swamp Lane,
  - o Including Watson Road,
  - o And including all the side streets off Watson Road
- South back along Nelsen Ridge Road and Golden Road until Springvale Road
- West back along Springvale Road until Cromwell-Clyde Road (SH 8)
  - Including McArthur Road,
  - Including Waipuna Road,
  - And including Waikerikeri Valley Road and all the side streets off Waikerikeri Valley Road
- North-west along Cromwell-Clyde Road (SH 8) until its intersection with Sunderland Road
  - Including Cromwell-Clyde Road (SH 8) to the north of Sunderland Road up to, and including, 2050 Cromwell Clyde Road

- West and then south along Sunderland Road until the Clyde Dam
- Jumps west across the Clutha River/Clyde Dam to Fruitgrowers Road
- South along Fruitgrowers Road until Earnscleugh Road
  - o Including Fruitgrowers Road to the north of the Clyde Dam
- South along Earnscleugh Road until Fraser Road
  - o Including Hawksburn Road down to and including number 990 Hawksburn Road
- South-west along Fraser Road until Strode Road
- South-east along Strode Road until its intersection with Hawley Road and McIntosh Road
  - o Including Strode Road to the north of Fraser Road

#### **Special Programmes**

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

# <u>Additional Entitlement to Enrol (Grandparenting)</u>

This provision has been approved for inclusion in the Clyde School enrolment scheme under Section 75 1(b) of the Education and Training Act 2020.

For families of currently enrolled students whose addresses become out of zone as a result of the amendment to this Enrolment Scheme Section 75 of the Education and Training Act 2020 states that:

"the Secretary may authorise an enrolment scheme to permit a student to enrol at the school as if the student lived in the home zone of the school if, -

- (a) in the case of an existing enrolment scheme whose home zone is amended, —
- (i) the student lives outside the amended home zone; and
- (ii) the student has a sibling who is enrolled at the school at the time that the amendment is implemented; and
- (iii) the sibling, at the time that the amendment is implemented, lives inside the home zone as it was before the amendment; and
- (iv) the student, at the time of enrolment, lives inside the home zone as it was before the amendment:

If applying for enrolment under this part of the Enrolment Scheme, the sibling's name and evidence of a sibling relationship may be required by the school.

<u>Section 75</u> of the Education and Training Act 2020 sets out the definition of a "sibling" for these purposes.

The school will maintain a list of students enrolled at the time of the implementation of the enrolment scheme change by the Board in order to enable determination of eligibility to enrol under this provision.

Note: That this is a very tightly defined definition. It would not apply to:

- 1. Children who move into the withdrawal area after the implementation of the enrolment scheme boundary amendment; or
- 2. Children of families/whānau who move out of the old zone after the implementation of the enrolment scheme boundary amendment.

## **Out of Zone Enrolments**

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

First Priority This priority is not applicable at this school because the school does not run

a special programme approved by the Secretary for Education.

**Second Priority** will be given to applicants who are siblings of current students. **Third Priority** will be given to applicants who are siblings of former students.

**Fourth Priority** will be given to any applicant who is a child of a former student of the school.

<u>Fifth Priority</u> will be given to any applicant who is either a child of an employee of the

board of the school or a child of a member of the board of the school.

**Sixth Priority** will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
