

## **Rimu School (4006)**

### **Enrolment Scheme**

Effective from 8 July 2003

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

#### **Home Zone**

**All students who live within the home zone described below shall be eligible to enrol at the school.**

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from (and including) number 373 East Road (SH 1), the home zone follows:

- North-east along East Road (SH 1) until it turns into Woodlands Invercargill Highway (SH 1)
- North-east along Woodlands Invercargill Highway (SH 1) until Longbush South Road
- South along Longbush South Road until Rimu Road
- East along Rimu Road until Stewart Road
- North then east along Stewart Road until Woodlands South Road
- South along Woodlands South Road until Rimu Road
- South-east along Rimu Road until its intersection with Rimu-Seaward Downs Road and Mokotua Road
- East along Rimu-Seaward Downs Road until Drakes Hill Road
- South-east along Drakes Hill Road until Waituna Road
- South-west along Waituna Road until Mokotua Road
- South along Mokotua Road until its intersection with Gorge Road Invercargill Highway and Clearwater Road
- South-west along Clearwater Road until Masseys Tramway Road
  - Including Clearwater Road to the south of Masseys Tramway Road
- West along Masseys Tramway Road until Longbush South Road
- North along the eastern side of Longbush South Road until Tapper Road
- From the intersection of Tapper Road and Longbush South Road jumps west to the end of Orr Road
- West along the northern side of Orr Road until Blondell Road
- North along Blondell Road until Nally Road
- West along Nally Road until Kennington Waimatua Road
- North along Waimatua Road until Rimu Road
  - Including Kennington Waimatua Road between Nally Road and Orr Road,
  - Including Mason Road from Kennington Waimatua Road until the Seward Bush Scenic Reserve,
  - Including Oteramika Road between Kennington Waimatua Road and Mill Road South,
  - And including Wilcox Road
- West along Rimu Road until Kennington Road

- West along Kennington Road until Clapham Road
  - Including Mclaw Road
- North along Clapham Road until East Road (SH 1)

### **Special Programmes**

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

### **Out of Zone Enrolments**

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

| <b><u>First Priority</u></b>  | This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.       |
| <b><u>Second Priority</u></b> | will be given to applicants who are siblings of current students.   |
| <b><u>Third Priority</u></b>  | will be given to applicants who are siblings of former students.  |
| <b><u>Fourth Priority</u></b> | will be given to any applicant who is a child of a former student of the school.  |
| <b><u>Fifth Priority</u></b>  | will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school. |
| <b><u>Sixth Priority</u></b>  | will be given to all other applicants.  |

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

**Applicants seeking second or third priority status may be required to give proof of a sibling relationship.**
