

Alexandra School (3701)
Enrolment Scheme
Effective from **31 January 2022**

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the intersection of Clyde-Alexandra Road (SH 8) and Airport Road, the home zone follows:

- South-east on the western side of Clyde-Alexandra Road (SH 8) until Boundary Road
- South-east on the western side of Centennial Avenue until Killarney Street
- East on the southern side of Killarney Street until Shannon Street
- East on Shannon Street until Tarbert Street (SH 85)
- North on the eastern side of Tarbert Street (SH85) until Little Valley Road
- East on Little Valley Road until the end of Little Valley Road
 - including Glencarron Street,
 - including Tucker Hill Road,
 - including Graveyard Gully Road,
 - and including Lookout Drive
- From the end of Little Valley Road travels back along Little Valley Road to its intersection with Tarbert Street (SH 85)
- South-west along the eastern side of Tarbert Street (SH 85) until its intersection with Shannon Street and Chapple Street
- East on Chapple Street until Fox Street
- South on Fox Street until Tarbert Street (SH 85)
 - including Coulson Place,
 - and including Kerry Street
- South on Tarbert Street (SH 85) until Walton Street
- East on Walton Street until Rivers Street
- East on Rivers Street until Tarbert Street
- North on Tarbert Street until Limerick Street
- West on Limerick Street until Kelman Street (SH 8)
- South-west on Kelman Street (SH 8) until it turns into The Half Mile (SH 8)
- South-west on The Half Mile (SH 8) until it turns into Alexandra-Fruitlands Road (SH 8)
 - including Old Bridge Road,
 - and including O'Neill Crescent)
- South-west on Alexandra-Fruitlands Road until it turns into Fruitlands-Roxburgh Road (SH 8) (including Butchers Ford Road and Lye Bow Road)
- South on Fruitlands-Roxburgh Road up to and including number 1772 Fruitland-Roxburgh Road (SH 8)

- including Symes Road
- From 1772 Fruitlands-Roxburgh Road travels back north along Fruitlands-Roxburgh Road and Alexandra-Fruitlands Road until Conroys Road
- North-west on Conroys Road until Earnsclough Road
 - including Sheephead Station Road,
 - and including Conroys Dam Road)
- North on Earnsclough Road until Blackman Road
 - including Earnsclough Road between Blackman Road and Mcpherson Road
- West on Blackman Road until Hawley Road
 - including McIntosh Road
- From the intersection of Blackman Road and Hawley Road travels east back along Blackman Road until Earnsclough Road
- South and then east on Earnsclough Road until The Half Mile (SH 8)
 - including Marshall Road,
 - and including Hart Place
- North-east on The Half Mile (SH 8) until Kelman Street (SH 8)
- North-west on Kelman Street (SH 8) until Dunorling Street
- South-west on Dunorling Street until Bringans Street
 - including Dunorling Street to the south-west of Bringans Street
- North-west on Bringans Street until Shannon Street
 - including Jackson Place
- South-west on Shannon Street until Orchard Drive
- North-west on Orchard Drive until Ashworth Street
 - including Walnut Grove,
 - including Gala Grove,
 - and including Cherry Grove
- North-west and around Ashworth Street until Beresford Street
 - including Clutha Street to the south-west of Ashmore Street,
 - including Eureka Street,
 - including Dawson Place,
 - including Don Place,
 - and including Campbell Street
- North-west on Beresford Street until Boundary Road
- South-west along Boundary Road until the end of Boundary Road
 - including all the side streets off Boundary Road
- North-east back along Boundary Road until Centennial Avenue (SH 8)

Transitional Arrangement

This provision has been approved for inclusion in the Alexandra School enrolment scheme under Section 75 1(b) of the Education and Training Act 2020.

The transitional arrangement is for families of currently enrolled students whose addresses become “out of zone” as a result of the implementation of this Enrolment Scheme.

Section 75 of the Education and Training Act 2020 states that;

“the Secretary may authorise an enrolment scheme to permit a student to enrol at the school as if the student lived in the home zone of the school if...

- (b) in the case of a new enrolment scheme, the student—
- (i) lives outside of the home zone of the new enrolment scheme; and
 - (ii) has a sibling who is enrolled at the school at the time that the new enrolment scheme is implemented.”

If applying for enrolment under this part of the Enrolment Scheme, the siblings name, and evidence of a sibling relationship may be required by the school.

[Section 75](#) of the Education and Training Act 2020 sets out the definition of a “sibling” for these purposes.

The school will maintain a list of students enrolled at the time of the implementation of the enrolment scheme by the Board in order to enable determination of eligibility to enrol under this provision.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

<u>First Priority</u>	This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
<u>Second Priority</u>	will be given to applicants who are siblings of current students.
<u>Third Priority</u>	will be given to applicants who are siblings of former students.
<u>Fourth Priority</u>	will be given to any applicant who is a child of a former student of the school.
<u>Fifth Priority</u>	will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
<u>Sixth Priority</u>	will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
