Enrolment schemes in Alexandra

As a parent or caregiver, you might have specific questions about enrolments and enrolment schemes. If it is not covered here, you should ask your school or email us –

Can I enrol a child at any school in Alexandra?

Not necessarily. Most state schools in Alexandra have enrolment schemes which help the School manage its roll. A school with an enrolment scheme has a home zone, which is a geographically defined area around the school.

- Students living inside the zone are guaranteed a place at the school.
- Students who live outside the zone can apply to enrol but acceptance of their application is subject to places being available for them – and if there are fewer places available than there are applicants, their acceptance is subject to the outcome of a pre-enrolment process called a ballot.

We are currently consulting over introducing an enrolment scheme for Alexandra Primary School. This means The Terrace School enrolment scheme will also be amended.

How do I know what the home zone is for schools in Alexandra?

Why does Alexandra Primary School need an enrolment schemes?

An enrolment scheme is a tool to help schools manage the roll. This is needed to prevent the risk of overcrowding and ensure that the school does not have more students than its facilities can cope with.

What is a home zone?

A defined geographical area, with its boundaries indicated by street names and numbers among other features.

Home zones are consulted over before being finalised – we need to understand any geographic, access or community implications before these come into effect. If we live inside the home zone of a state school, does that school have to accept our enrolment application?

Yes. Living in the enrolment scheme home zone means you have entitlement to enrol your child at that school. It's important to note that schools may ask for proof that you genuinely live at the address in the home zone, and it's your responsibility to provide evidence to show this.

If we live outside the home zone of a state school, can we still get my child into that school?

Not necessarily. Schools can enrol some out of zone students, but only if the Board of Trustees determines it has space available after all in-zone students are enrolled or planned for.

There are processes that Boards follow to enrol out of zone students, and these only happen at certain time of the year. More information can be found about these processes [here](#) or by contacting the School for more information.

If we live one street or a few street numbers away from a school's home zone boundary, can my child still attend the school?

No. You are considered to be outside the zone and should refer to the question above.

My children attend The Terrace School, where the boundary of its home zone is proposed to change. Currently we live inside the zone, but we won't when it changes. Will my children be able to continue attending the school?

Yes. When a home zone changes, current students who are living at an address that becomes out-of-zone are allowed to continue at the school.

The enrolment scheme legislation allows for transitional arrangements for families impacted by zoning changes. This will be introduced for The Terrace School and will mean that in certain circumstances, siblings of current The Terrace students living in this area, may also be entitled to enrol at The Terrace School. This is commonly known as 'grandparenting'.

What is grandparenting or a transitional arrangement?

A transitional arrangement (often referred to as grandparenting) can be included in new or amended zones to help reduce the impact of enrolment schemes to families that are already enrolled at the school. This means that younger siblings can enrol at the same school as their older brother or sister and gives families certainty about their enrolment eligibility, without having to wait for an out of zone process. It means these students would be treated as in-zone and have the same entitlement to enrol as if they lived in the home zone.

Transitional arrangements do not apply to everyone – criteria must be met. This is outlined for both The Terrace School and Alexandra Primary School below.

How will grandparenting (transitional arrangement) work for Alexandra Primary School?

We are considering including a transitional agreement for **Alexandra Primary School**. This will be a transitional arrangement for a *new enrolment scheme*.

From 2022, if approved, the transitional arrangement applies for new enrolments if you can answer 'yes' to both of the questions below:

Criteria to be met	Yes or No?
New student enrolling lives outside the home zone of Alexandra Primary School	
New student enrolling has a sibling already enrolled at Alexandra Primary School at the time the enrolment scheme is implemented (expected to be start of Term 1, 2022 – exact date to be confirmed)	

If both criteria are met, the new student enrolling will be entitled to enrol and attend Alexandra Primary School. The School may request evidence to verify the information before enrolling a new student under the transitional arrangement.

The Terrace School – transitional arrangement for an *amended enrolment scheme*

From 2022, if approved, the transitional arrangement applies for new enrolments if you can answer 'yes' to all the questions below:

Criteria to be met	Yes or No?
New student enrolling lives outside the amended home zone of The Terrace School	
New student enrolling has a sibling who was enrolled at The Terrace School at the time the amended enrolment scheme was adopted (expected to be end of 2021 – exact date to be confirmed)	
The sibling already enrolled at The Terrace School, at the time the amendment is adopted (expected to be end of 2021) lives inside the home zone as it was before the amendment	
New student enrolling lives in the home zone as it was before the amendment, at the time of their enrolment	

If all four criteria are met, the new student enrolling will be entitled to enrol and attend The Terrace School. The School may request evidence to verify the information before enrolling a new student under the transitional arrangement.
