

# Goldfields School (3741)

## Enrolment Scheme

Effective from Day Month Year

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

### Home Zone

**All students who live within the home zone described below shall be eligible to enrol at the school.**

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from 2437 Luggate-Cromwell Road, the home zone follows:

- South along the western side of Luggate-Cromwell Road until Shortcut Road
- East along the southern side of Shortcut Road until Lakeview Terrace
- South along the western side of Shortcut Road until State Highway 8B
- West along the northern side of State Highway 8B until Barry Avenue
- South along the western side of Barry Avenue until Bannockburn Road
- South-west along the western side of Bannockburn Road until the Kawarau River
- North-west along the northern bank of the Kawarau River until and including 3207 Gibbston Highway
- From 3207 Gibbston Highway travels east back along Gibbston Highway until Kawarau Gorge Road
- South-east along Kawarau Gorge Road until Ripponvale Road
- North-east along Ripponvale Road until Kawarau Gorge Road
  - Including Ritchies Road
- North-east along Kawarau Gorge Road until Luggate-Cromwell Road
- North-east along the western side of Luggate-Cromwell Road until 2437 Luggate-Cromwell Road
  - Including all side streets on the western side of Luggate-Cromwell Road between Shortcut Road and 2437 Luggate-Cromwell Road.

### Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

### Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium

appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

| <b><u>First Priority</u></b>  | This priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.       |
| <b><u>Second Priority</u></b> | will be given to applicants who are siblings of current students.   |
| <b><u>Third Priority</u></b>  | will be given to applicants who are siblings of former students.  |
| <b><u>Fourth Priority</u></b> | will be given to any applicant who is a child of a former student of the school.  |
| <b><u>Fifth Priority</u></b>  | will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school. |
| <b><u>Sixth Priority</u></b>  | will be given to all other applicants.  |

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

**Applicants seeking second or third priority status may be required to give proof of a sibling relationship.**
