

GREENPARK SCHOOL (1729)

ENROLMENT SCHEME

01 JANUARY 2024

The guidelines for the development and operation of enrolment schemes are issued under section 72(1) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school:

Starting at the mouth of the Waimapu Stream, as it enters the Waimapu Estuary, the enrolment zone boundary travels eastward, along the coastline to 102 College Place. From here the boundary travels south, behind (and excluding) addresses on Hinaki Street, Inaka Place and Papaka Lane, to SH29A.

The boundary travels south, along the centre of SH29A to the roundabout with Poike Road. From this roundabout the boundary travels east along Poike Road to the intersection of Poike Road and Waimapu Pa Road.

From this intersection the boundary travels south behind (and including) addresses on Waimapu Pa Road, to the Waimapu Stream behind 11 Pukemapu Road (this address is excluded from the zone).

From here the boundary travels south, along the west bank of the Waimapu Stream, to the rear of 3 Pukemapu Rod (which lies at the intersection of Pukemapu and Oropi Roads. This address is excluded from the zone). The boundary continues directly north-west across Oropi Road to capture 218 Oropi Road and on to the Waiorohi Stream (adjacent to the Renner Park Golf Course).

The boundary follows the Waiorohi Stream south to Joyce Road, then pivots northwest, along the centre of Joyce Road, capturing odd-numbered addresses only, to 225 Pyes Pa Road, which lies at the intersection of Joyce Road and Pyes Pa Road (this address is included in the zone).

From 225 Pyes Pa Road, the boundary travels south along Pyes Pa Road to the intersection with Kennedy Road. From this intersection the boundary travels around (and includes) 2 Kennedy Road, then pivots to travel northward behind (and including) even-numbered addresses on Pyes Pa Road to the north-west boundary of 202 Pyes Pa Road.

From this point the boundary travels north-west behind (and including) addresses on Freeburn Road, Molloy Rise, Bradley Ave, and Jason Place, to 52C Pyes Pa Road (included in the zone). From 52C Pyes Pa Road, the boundary continues north, behind and including 561 and on to SH29A.

The boundary then travels west along the centre of SH29A, capturing even-numbered addresses only, to the Kopurererua Stream crossing. The boundary pivots north, following the Kopurererua Stream to the north-west boundary of the Tauranga Golf Course, then

pivots south-east, around (and including) the golf course to Cameron Road.

From this point the boundary travels south-west along the centre of Cameron Road, to the intersection with Oban Road.

From this intersection the boundary travels behind (and including) address on Oban Road, and around the edge of Morland Fox Park (this park is excluded from the zone). The boundary travels behind (and includes) the Greerton Aquatic and Leisure Centre and continues on to the rear of 23 Devon Street (this address is included in the zone).

From 23 Devon Street, the boundary travels south-west along the centre of this road, including odd-numbered addresses only, to the intersection of Devon Street and Kiteroa Street.

From this intersection the boundary travels south-east along the centre of Kiteroa Street, including even-numbered addresses only, to the intersection of Rawhiti Street and Kiteroa Street.

From this intersection the boundary travels north-east along the centre of Rawhiti Street, capturing even-numbered addresses only, to the intersection of Rawhiti Street and Pooles Road.

From this intersection the boundary pivots east behind (and including) the North Island Mussel processing plant on Glenlyon Ave, and on to Oropi Road. The boundary captures 56 Oropi Road, then continues east behind (and including) even-numbered addresses on Oropi Road, to the Waimapu Stream.

The boundary follows the east bank of the Waimapu Stream to its mouth into the Waimapu Estuary.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Special Programmes

The school does not operate any special programmes.

Applications for enrolments will be processed in the following order of priority:

- **First priority** must be given to students who have been accepted for enrolment in the above special programme(s) run by the school and approved by the Secretary for Education.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the

board of the school or a child of a member of the board of the school.

- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Schedule 20 (2) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Proof of residence within the home zone may be required.

Transitional Arrangements

For families of currently enrolled students whose addresses become out of zone as a result of the amendment of this Enrolment Scheme.

Section 75 of the Education and Training Act 2020 states that,

“The Secretary may authorise an enrolment scheme to permit a student to enrol at the school as if the student lived in the home zone of the school if,

- (a) in the case of an existing enrolment scheme whose home zone is amended, —
 - (i) the student lives outside the amended home zone; and
 - (ii) the student has a sibling who is enrolled at the school at the time that the amendment is implemented; and
 - (iii) the sibling, at the time that the amendment is implemented, lives inside the home zone as it was before the amendment; and
 - (iv) the student, at the time of enrolment, lives inside the home zone as it was before the amendment:
- (b) in the case of a **new enrolment scheme**, the student,
 - (i) lives outside of the home zone of the new enrolment scheme; and
 - (ii) has a sibling who is enrolled at the school at the time that the new enrolment scheme is implemented.

This provision has been approved for inclusion in this Enrolment Scheme for a period of **2 years** from the 1st January 2024.

If applying for enrolment under this part of the Enrolment Scheme, the siblings name, and evidence of a sibling relationship may be required by the school.

Section 75 of the Education and Training Act 2020 sets out the definition of a “sibling” for these purposes.

The school will maintain a list of students enrolled at the time of the implementation of the enrolment scheme and its adoption by the board to enable determination of eligibility to enrol under this provision.
