Heriot School (3749) Enrolment Scheme

Effective from Day Month Year

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

The Home Zone takes addresses on both sides of the boundary roads mentioned in the description unless otherwise stated.

Starting from the intersection of Paradise Flat Road and Ardmore Road, the home zone follows:

- North-west along Paradise Flat Road until the end of Paradise Flat Road
- From the end of Paradise Flat Road continues North-west along the northern and then eastern bank of the Pomahaka River until it meets with the end of Hukarere Station Road
- North-east along Hukarere Station Road until Wilden Runs Road
- East along Wilden Runs Road until Aitchison Runs Road
- North along Aitchison Runs Road until Mackay Road
 - o Including Aitchison Runs Road to the north of Mackay Road
- East along Mackay Road until Wilden School Road
- East along Wilden School Road until its intersection with Moa Flat Road
- East along Moa Flat Road until Edievale Road
 - Including Keppoch Road
- East along Edievale Road until Winter Road
- East along Winter Road until Haugh Road
- South-west along Haugh Road until Corkscrew Road
 - Including Haugh Road to the east of Winter Road
- South-east along Corkscrew Road until Edievale Road
 - Including Caffell Road
- South-east along Edievale Road until Tapanui Raes Junction Highway (SH 90)
- East along Tapanui Raes Junction Highway (SH 90) up until and including 2435 Tapanui Raes Junction Highway (SH 90)
- From 2435 Tapanui Raes Junction Highway (SH 90) travels west back along Tapanui Raes Junction Highway (SH 90) until Crookston Road
 - Including Sims Road,
 - Including Gorge Road,
 - o And including Westwood Road
- West along Crookston Road until Fleming Road
 - Including Tapanui Raes Junction Highway (SH 90) to the South of Crookston Road down until and including 1036 Tapanui Raes Junction Highway,
 - And including Revie Road
- South along Fleming Road until Black Gully Road West

- West along Black Gully Road West until Mill Road
- South-west along Mill Road until Walker Road
- West along Walker Road until Ardmore Road
 - o Including Gibson Road up to number 80 Gibson Road
- South along Ardmore Road until Paradise Flat Road.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by public notice in a medium appropriate to the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

First Priority This priority is not applicable at this school because the school

does not run a special programme approved by the Secretary

for Education.

Second Priority will be given to applicants who are siblings of current

students.

Third Priority will be given to applicants who are siblings of former students.

Fourth Priority will be given to any applicant who is a child of a former student

of the school.

Fifth Priority will be given to any applicant who is either a child of an

employee of the board of the school or a child of a member of

the board of the school.

Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary, under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
