# KAITOKE SCHOOL | WANGANUI (#2372)

## **Draft Amended Enrolment Scheme Description**

#### Effective from .....

The guidelines for the development and operation of enrolment schemes are issued under Schedule 20 of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

#### Home Zone

All students who live within the home zone described below and/or shown on the attached map shall be entitled to enrol at the school. Both sides of each road are included in the zone unless otherwise stated.

In a clockwise direction:

- 1. The zone starts at the confluence of the Whanganui River and the Tasman Sea and follows the south bank of the Whanganui River east to its intersection with State Highway 3.
- 2. From the intersection of the Whanganui River and State Highway 3 the zone travels east on State Highway 3 to its intersection with Putiki Drive. Only properties numbered on the southern side of State Highway 3 are in zone.
- 3. From the intersection of State Highway 3 and Putiki Drive, the zone follows State Highway 3 east to its intersection with Hewitts Road. Only properties numbered on the southern side of State Highway 3 are in zone.
- 4. At the intersection of State Highway 4 and Hewitts Road the zone follows Hewitts Road to the end of the road before returning to its intersection with State Highway 4.
- 5. From the intersection of Hewitts Road and State Highway 3 the zone travels east on State Highway 3 to its intersection with Concord Line. All addresses on Holmwood Road are in zone.
- 6. At the intersection of State Highway 3 Concord Line the zone follows Concord Line east until the end of the road, then returns to State Highway 3. All properties numbered on Concord Line are in zone.
- 7. From the intersection of Concord Line and State Highway 3 the zone then follows State Highway 3 east to the eastern boundary of 863 State Highway 3. 901 State Highway 3 is not in zone.
- 8. From the eastern boundary of 863 State Highway 3 the zone returns west on State Highway 3 to its intersection with Marangai Road.
- 9. At the intersection of State Highway 3 and Marangai Road the zone travels south to the end of Marangai Road. All addresses numbered on Marangai Road are in zone.
- 10. From the end of Marangai Road the zone travels southwest overland to the confluence of the Whangaehu River and the Tasman Sea.
- 11. From the confluence of the Whangaehu River and the Tasman Sea the zone follows the coastline north to the starting point at the confluence of the Tasman Sea and the Whanganui River.

#### **In-Zone Enrolments**

Proof of residence within the home zone may be required.

Each year applications for enrolment from in-zone students will be sought by a date which will be published by notice on the school website, and in a media suitable for the local community. This will enable the school board to assess the number of places which can be made available to students who live outside the home zone. (*This paragraph is optional*)

### **Out of Zone Enrolments**

Each year the board will determine the number of places, and the number of pre-enrolment periods, which are likely to be available in the following year for the enrolment of students who live outside the home zone. The school board will publish this information by notice in a media suitable for the school and wider local community. The notice will indicate how applications are to be made, the date by which all applications must be received, and the date any ballot will be held.

Applications for enrolment will be processed in the following order of priority, according to legislation:

First Priority	This priority category is not applicable to this school as it does not operate a special programme approved by the Secretary of Education.
Second Priority	will be given to applicants who are siblings of current students.
Third Priority	will be given to applicants who are siblings of former students.
Fourth Priority	will be given to any applicant who is a child of a former student of the school.
Fifth Priority	will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
Sixth Priority	will be given to all other applicants.

Note: Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Clause 3 Schedule 20 of the Education and Training Act 2020.
