

# Kiwitea School (2382)

## Enrolment Scheme Description

Effective from xxxxx, 2021

The guidelines for the development and operation of enrolment schemes are issued under Schedule 20 of the Education and Training Act 2020 for the purpose of describing the basis on which the

Secretary's powers in relation to enrolment schemes will be exercised.

### Home Zone

All students who live within the home zone described below and/or shown on the attached map shall be entitled to enrol at the school. Both sides of each road are included in the zone unless otherwise stated. Proof of residence within the home zone may be required.

- 1. The zone begins at the intersection of Kimbolton Road (State Highway (SH) 54) and Bell Road East.*
- 2. The zone travels west to the end of Bell Road East. All properties on Bell Road East are in zone.*
- 3. The zone then returns along Bell Road East until Kimbolton Road (SH 54) and turning left, proceeds along Kimbolton Road (SH 54) to the intersection with Cheltenham-Hunternville Road.*
- 4. The zone then turns left and travels northwest along Cheltenham-Hunternville Road until the intersection of Cheltenham-Hunternville Road and Cheltenham Cross Road, including 2697 Cheltenham-Hunternville Road.*
- 5. The zone proceeds through the intersection and continues along Cheltenham-Hunternville Road until the intersection of Cheltenham-Hunternville Road and Beaconsfield Valley Road.*
- 6. The zone turns right onto Beaconsfield Valley Road and proceeds along Beaconsfield Valley Road until the intersection of Beaconsfield Valley Road and Haynes Line. All properties numbered on Beaconsfield Valley Road until Haynes Line are in zone.*
- 7. The zone proceeds through the intersection and continues on Beaconsfield Valley Road until the intersection of Beaconsfield Valley Road and Jens Road.*
- 8. The zone turns right on Jens Road and proceeds in an easterly direction along Jens Road until the end of the road. 86a Jens Road is in zone.*
- 9. The zone then proceeds from the end of Jens Road in a straight line across country to meet the end of Low Road.*

10. *The zone then proceeds along Low Road in an easterly direction until the intersection of Low Road and McBeth Road. 345 McBeth Road is in zone. 403 McBeth Road is out of zone.*
11. *The zone then proceeds south east on Bryce Road until the intersection with Kimbolton Road.*
12. *The zone then turns left and proceeds north east on Kimbolton Road as far as and including 2522 and 2523 Kimbolton Road.*
13. *From 2522 Kimbolton Road the zone now travels south east along the boundary line of 2522 Kimbolton Road until it reaches 381 Te Awa Road. 381 Te Awa Road is in zone.*
14. *The zone then proceeds in a north east direction along Te Awa Road until the intersection of Te Awa Road and Ridge Road.*
15. *The zone turns left onto Ridge Road and proceeds northeast along Ridge Road until 1396 Ridge Road, which is in zone.*
16. *The zone then returns along Ridge Road and through the intersection with Te Awa Road and proceeds along Ridge Road in a south westerly direction until the intersection with Finnis Road. No properties on Finnis Road are in zone.*
17. *The zone then returns north east along Ridge Road until the intersection with Pollock Road.*
18. *The zone then turns left and travels west along Pollock Road until the Creamery Road intersection. No properties on Creamery Road, nor on Pollock Road west of Creamery Road are in zone.*
19. *At the intersection of Pollock Road and Creamery Road the zone travels across country in a straight line, following the boundary of 207 Pollock Road north until Oroua River.*
20. *The zone follows the Oroua River in south westerly direction until it reaches the southern end of Barrow Road, and then proceeds northwest on Barrow Road until the intersection with Kimbolton Road. All properties numbered off Barrow Road are in zone.*
21. *The zone turns left onto Kimbolton Road and proceeds south west until the intersection with Almadale Road. All properties numbered off Kimbolton Road are in zone*
22. *The zone then turns left and proceeds southeast to the end of Almadale Road.*
23. *The zone then returns to Kimbolton Road, re-joining the starting point of the zone. All properties numbered off Almadale Road are in zone.*

## In-Zone Enrolments

Proof of residence within the home zone will be required.

Each year applications for enrolment from in-zone students will be sought by a date which will be published by notice on the school website, and in a media suitable for the local community. This will enable the school board to assess the number of places which can be made available to students who live outside the home zone.

## Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available for the enrolment of students who live outside the home zone. The school board will publish this information by notice on the school website, and in a media suitable for the local community. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority, according to legislation:

| <b>First Priority</b>  | <i>This priority category is not applicable to this school.</i>   |
| <b>Second Priority</b> | will be given to applicants who are siblings of current students.   |
| <b>Third Priority</b>  | will be given to applicants who are siblings of former students.  |
| <b>Fourth Priority</b> | will be given to any applicant who is a child of a former student of the school.  |
| <b>Fifth Priority</b>  | will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school. |
| <b>Sixth Priority</b>  | will be given to all other applicants.  |

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under the Education and Training Act 2020.

Parents will be informed of the date of any ballot by media suitable to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
