# MARIAN COLLEGE (343) Proposed Enrolment Scheme Amendment

Marian College is a Catholic state integrated secondary school for girls.

Qualifying Parishes means one of the following Catholic Parishes as defined by the Diocese:

- Cathedral Parish
- Christchurch East Parish
- Christchurch North Parish
- Waimakariri St Peter Chanel Parish

# **Priority of Enrolment**

All applications made pursuant to its conditions of enrolment, which have been received at the College by the Closing Date, shall be processed in accordance with the following order of priority:

- Priority 1 Preference Applicants who, on the Closing Date, reside in a Qualifying Parish; and
  - (i) Attend the following Catholic primary schools:
    - Christ the King
      - New Brighton Catholic New Brighton
      - Our Lady Star of the Sea Sumner
      - St Anne's Woolston
      - St Francis of Assisi
      - St Joseph's Papanui
      - St Joseph's Rangiora
      - St Mary's City North
      - St Patrick's Bryndwr
      - St Patrick's Kaiapoi; OR
  - (ii) Are former students who completed Year 6 at one of the following Catholic primary schools:
    - St James Aranui
    - St Albans Catholic St Albans.
- **Priority 2** Preference Applicants who, on the Closing Date, reside in a Qualifying Parish; and
  - 1. are sisters of current students; then
  - 2. are sisters of former students; then
  - 3. are daughters of past students; then
  - 4. are daughters of Employees; then
  - 5. are daughters of current members of the Board.
- **Priority 3** Preference Applicants who, on the Closing Date, reside in a Qualifying Parish.
- Priority 4 Preference Applicants who, on the Closing Date, reside in any Catholic parish within the Diocese other than a Qualifying Parish and who attend the Catholic primary schools listed in Priority 1(i) or are former students of the Catholic primary schools listed in Priority 1(ii).
- **Priority 5** Preference Applicants who, on the Closing Date, reside in any Catholic parish within the Diocese other than a Qualifying Parish.

- **Priority 6**Non-Preference Applicants who, on the Closing Date, reside in a Qualifying Parish and who attend the Catholic primary schools listed in Priority I(i) or are former students of the Catholic primary schools listed in Priority I(ii).
- **Priority 7** Non-Preference Applicants who, on the Closing Date, reside in a Qualifying Parish; and
  - 1. are sisters of current students; then
  - 2. are sisters of former students; then
  - 3. are daughters of past students; then
  - 4. are daughters of Employees; then
  - 5. are daughters of current members of the Board.
- **Priority 8** Non-Preference Applicants who, on the Closing Date, reside in a Qualifying Parish.
- **Priority 9** Non-Preference Applicants who, on the Closing Date, reside in any Catholic parish within the Diocese other than a Qualifying Parish.

### **Notification of Enrolment Date**

Each year, applications for enrolment will be sought by a date which will be publicly notified by publishing that date on the school website and in a daily or community newspaper circulating in the area served by the College.

### **Non-Preference Enrolment**

Non-preference students may be considered for enrolment only if enrolment places remain after all preference applicants have been enrolled and the total roll is still less than the maximum specified in our Integration Agreement. The maximum number of places available for non-preference students will be governed by the maximum allowable under the College Integration Agreement which for Marian College is 5% of the total roll.

## Non-Preference Criteria

- The applicants accept they will be attending a Catholic Special Character school and that their place is conditional on their participation in the Catholic Special Character of the College.
- The applicants accept that they will be required to pay attendance dues as set by the Proprietor and these are compulsory.

# **Waiting List**

If the total number of Applicants is greater than the number of places available,

- Unsuccessful Applicants will have their names recorded on a waiting list, within their relevant priority category which shall include the order in which they were drawn in any **ballot** (if applicable).
- Students on the waiting list may be offered places at a later date if they become available.
- The waiting list will remain current and in effect until the 31 January in the year of entry.

#### **Pre-Enrolment**

If it is determined that there are more Applicants within any of the priority categories 1-9 (inclusive) than there are places available at the College, they shall be allocated amongst hitherto unsuccessful Applicants at each priority level 1-9 by result of **ballot**.

#### **Maximum Roll**

The student roll of the College will be managed within the Maximum Roll and in terms of the Private Schools Conditional Integration Act 1975.

#### **Definitions**

"Applicant" means a student applying for acceptance on to the student roll of the College.

"The Board" means The Board of Trustees of Marian College.

"Closing Date" means the publicly notified date in each year by which applications for enrolment at the College are to be received.

"College" means Marian College.

"Diocese" means the Catholic Diocese of Christchurch.

"Employee" means a person employed directly by the College on either a fixed term employment agreement or on an enduring agreement for continuous employment.

"Maximum Roll" means the maximum number of students that should be enrolled for attendance at the College as prescribed from time to time under its Integration Agreement.

"Non-preference Applicants" means Applicants who do not hold a Preference of Enrolment Certificate.

"Preference Applicants" means Applicants who hold a Preference of Enrolment Certificate.

"Qualifying Parish" means one of the following Catholic Parishes as defined by the Diocese:

- Cathedral Parish
- Christchurch East Parish
- Christchurch North Parish
- Waimakariri St Peter Chanel Parish

Words which refer to the singular shall include the plural and vice-versa.
