

PYES PĀ SCHOOL (1916)

ENROLMENT SCHEME

01 JANUARY 2024

The guidelines for the development and operation of enrolment schemes are issued under section 72(1) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

Starting from the roundabout where Takitimu Drive (SH36) and Pyes Pa Road intersect, travel north to the intersection with Joyce Road. From here travel east along Joyce Road and continue east to the Waiorohi Stream.

Follow the Waiorohi Stream south to the rear boundary of 1002B Oropi Road (this address is excluded from the zone).

From this point, continue south, along the eastern boundary of addresses on Oropi Gorge Road, to the intersection of Oropi Gorge Road and Glue Pot Road. Addresses 355B Glue Pot Road and 333 Glue Pot Road are included in the zone; all other addresses on Glue Pot Road are excluded from the zone.

From 333 Glue Pot Road (the intersection with Oropi Gorge Road and Glue Pot Road) travel south-west to the rear of addresses on Pyes Pa Road. Travel south along the eastern boundary of odd-numbered addresses on Pyes Pa Road and then cross Oropi Road at the bridge over the Tautau Stream. From this point, travel in a straight line in a south-east direction to the intersection of No. 2 Road and Mountain Road.

From the intersection of No. 2 and Mountain Roads, travel along the Otanewainuku Rimu Loop track, onwards north to the rear of 1384 No. 3 Road. This address is excluded from the zone. From this point, travel south to 1515 No 2 Road (this address is excluded from the zone), and then further south to the point where the Whataroa and Waiari Streams meet.

Follow the east bank of the Whataroa Stream in a south-west direction to the point where the Whataroa Stream meets the Taumatapaua Stream. From this point, divert south-west to 2466 Te Matai Road.

From this point travel west along Te Matai Road, capturing even numbered-addresses only, to the intersection of Te Matai Road and Pyes Pa Road (SH36). From this intersection travel south along Pyes Pa Road to the bridge over Ohaupara Stream (Bridge 280).

From here, travel along the eastern bank of the Ohaupara Stream to its end, then continue south-west to 354 Ngawaro Road. This address is excluded from the zone. From this point, travel north, to Puwhenua (Mountain). Puwhenua is excluded from the zone.

From Puwhenua travel north-east to 1870 Omanawa Road (this address is excluded from the zone). From here, travel north along Omanawa Road, capturing odd-numbered addresses

only, to the southern boundary of 1331 Omanawa Road (this address is excluded from the zone).

From this point, travel north-east to capture 19 Sarona Park Drive (all other addresses on Sarona Park Drive are excluded from the zone). From this point, travel directly north to the Omanawa Falls, then directly to 823 Belk Road (this address is excluded from the zone).

From the eastern boundary of 832 Belk Road, follow the Kopurererua Stream to capture 207 Keenan Road. Capture all properties on Keenan Road and continue east to ACG Tauranga (School), then cross Pyes Pa Road to the Cemetery.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Special Programmes

The school does not operate any special programmes

Applications for enrolments will be processed in the following order of priority:

- **First priority** must be given to students who have been accepted for enrolment in the above special programme(s) run by the school and approved by the Secretary for Education.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Schedule 20 (2) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Proof of residence within the home zone may be required.
