

Description of the enrolment zone for Tauhara College

Starting at the lake edge in front of 1 Lowell Place, the boundary travels south along the shoreline to the point perpendicular to the intersection of State Highway 1 and Te Heuheu Road, Waitahanui.

The boundary leaves the shoreline at this point, and travels east to the intersection itself, then continues eastward, travelling down the centre of Te Heuheu Road to the end of that road.

From the end of Te Heuheu Road, the boundary travels directly to the south shore of Lake Hinemaiaia. From here, the boundary travels in straight, south-eastly direction, to the Kaimanawa Forest Park (where the Te Arero Stream enters the Park.)

At this point the boundary proceeds eastward along the edge of the Kaimawa Forest Park, to reach Poronui Hut.

From Poronui Hut the boundary heads east, following the Mohaka River to where it meets with the Otupua Stream.

The boundary pivots at this junction, travelling north along the Otupua Stream. The boundary then travels east, around (and including) Lochinver Station, to the intersection of State Highway 5 and Matea Road.

From this intersection, the boundary travels northward, around (and including), properties on Matea Road, to the Mangatiti Stream.

The boundary follows the Mangatiti Stream northward, to the junction of the Stream with the Rangitaiki River. From this river junction, the boundary proceeds in a straight line north-west, to the rear of properties on Tiverton Downs Road (addresses on Tiverton Downs Road are excluded from the zone).

From here the boundary travels to the rear of 1760 Broadlands Road, travelling north-east behind 1776, 1780 and 1810 Broadlands Road. All of these addresses are included in the zone. At 1810 Broadlands Road, the boundary crosses to capture 1815 Broadlands Road, and the travels north-west to the Waikato River, capturing 1827 and 1829 Broadlands Road.

At the rear of 1829 Broadlands Road, the boundary follows the Waikato River south to the rear of 1667 Broadlands Road, then pivots south, capturing 1665 Broadlands Road. The boundary then travels west along the centre of Broadlands Road, capturing even-numbered addresses only, to the northern boundary of number 263 Broadlands Road.

From here the boundary runs behind (and excludes) addresses on Centennial Drive, to number 334 Centennial Drive (also excluded from the zone). The boundary then travels west along the centre of Centennial Drive, capturing even-numbered

addresses only, and then along the centre of Spa Road, to the intersection of Spa Road and Tauhara Road.

The boundary pivots east, travelling along the centre of Tauhara Road, capturing even-numbered addresses only, to the intersection of Tauhara Road and Rifle Range Road.

The boundary then travels south-west behind (and excluding) odd-numbered addresses on Rifle Range Road, all the way to number 7 Rifle Range Road.

From behind 7 Rifle Range Road (excluded from the zone), the boundary returns to Rifle Range Road connects to Lake Terrace.

From this intersection the boundary travels along the lake edge directly to the intersection of Lake Terrace and Lowell Place, including all numbers on Lake Terrace from 70 Lake Terrace to 208 Lake Terrace, as well as all addresses on Lowell Place.
