ENROLMENT SCHEME TAUHARA SCHOOL (1984)

The guidelines for the development and operation of enrolment schemes are issued under section 72(1) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.

Starting from the intersection of Tauhara Road and AC Baths Ave, the zone boundary travels south-east along Tauhara Road, capturing even-numbered addresses only, to the intersection of Hatton Street and Tauhara Road.

From the intersection Hatton Street and Tauhara Road the boundary travels behind (and excludes) addresses on Hatton Street to the intersection of Hatton and Elizabeth Streets. From this intersection the boundary crosses Elizabeth Street to 49 Elizabeth Street (included in the zone) and continues south-east behind (and including) odd-numbered addresses on Elizabeth Street to the rear of 2/59 Elizabeth Street (included in the zone). From this address the boundary travels south-west, to capture 50 Brice Street.

From 50 Brice Street the boundary crosses Brice Street continues south-west behind (and excluding) address on Brice Street to the intersection of Taharepa Road, Hatepe Ave and Brice Street.

From this intersection the boundary continues south-west behind (and excluding) oddnumbered addresses on Hatepe Ave to the intersection of Tamamutu Street. From this intersection the boundary travels south-east along the centre of Tamamutu Street, capturing even-numbered addresses only, to Gillies Ave.

From the intersection of Tamamutu Street and Gillies Ave, the boundary pivots north-east, travelling along the centre of Gillies Ave, capturing even-numbered addresses only, to the intersection with Tamatea Road, then pivots south-east along the centre of Tamatea Road, including even-numbered addresses only, to the intersection with Taharepa Road.

From the intersection of Tamatea Street and Taharepa Road the boundary travels to the Taharepa Road/Kiddle Drive roundabout, then south-east along the centre of Kiddle Drive (capturing even-numbered addresses only) to the intersection of Kiddle Drive, Napier Road and Arrowsmith Ave.

From the intersection of Kiddle Drive, Arrowsmith Ave and Napier Road, the boundary travels east along the centre of Napier Road, capturing even-numbered addresses only, to the roundabout where Napier Road, the Eastern Taupo Arterial Road and State Highway 5 meet. From this roundabout the boundary continues east along the centre of State Highway 5, capturing odd-numbered addresses only, (and excluding all addresses on Mountain Road), to the Opepe Scenic and Historic Reserve site. From the Opepe Scenic Historic Reserve on State Highway 5, the boundary pivots north-east in a straight line, crossing the Pueto Stream, and Little Creek, continuing around the airstrip and on to Sexton Stream. The boundary travels northward, just east of the Sexton Stream and on to the fork of the Sexton and Pueto Streams.

From this fork, the boundary travels directly north to Broadlands Road, then west along the centre of Broadlands Road (capturing even-numbered addresses only) to the intersection of Broadlands Road and Off Road Highway.

From this intersection the boundary travels west along the centre of Off Road Highway to the rear of 35 Titan Way (this address is excluded from the zone), then directly south to Centennial Drive.

The boundary travels west along the centre of Centennial Drive, capturing even-numbered addresses only, around the Taupo Golf Club House (excluded from the zone) and behind (and excluding AC Baths and sports facilities), to AC Baths Ave. The boundary travels south down the centre of AC Baths Ave, and ends at the intersection of Tauhara Road and AC Baths Ave.

Proof of residence within the home zone will be required. Proof will include any accounts or bank statements sent to the required address.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Special Programmes

Tauhara School operates a Māori Medium (rumaki) programme and this is included as a special programme within this enrolment scheme.

Applications for enrolments will be processed in the following order of priority:

- **First priority** must be given to students who have been accepted for enrolment in the above special programme(s) run by the school and approved by the Secretary for Education.
- Second priority must be given to applicants who are siblings of current students.
- Third priority must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Schedule 20 (2) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Proof of residence within the home zone may be required.
