

# TE ORAKA (3503)

## Enrolment Scheme

### Home Zone

**All students who live within the home zone described below shall be eligible to enrol at the school.**

Starting from the intersection of Madras Street and Purchas Street;

- North along the eastern side only of Madras Street to Forfar Street
- North along east side only of Forfar Street to Warrington Street
- North through the walkway to Forfar Street
- North west along the eastern side only of Forfar Street to Mayfield Avenue
- North east along Mayfield Avenue up to and including addresses 37 Mayfield on the western side and up to and including 46 Mayfield on the eastern side.
- North east across to and including addresses 65 and 62 Francis Avenue
- North east from 62 Francis Avenue to address 77 Flockton Street (inclusive)
- South east from 77 Flockton Street to Thornton Street
- North east along Thornton Street to Aylesford Street
- South east along Aylesford Street to Hills Road
  - Including addresses on Aylesford Street between Thornton Street and Crosby Street.
- North along Hills Road to Whitehall Street
  - Including Spurway Place and Friel Lane.
- North along the eastern side only of Hills Road to Akaroa Street
- North east along the south-eastern side only of Akaroa Street to Briggs Road
- East along the southern side only of Briggs Road to Marshland Road / Lake Terrace Road intersection
- East along the southern side only of Lake Terrace Road to Horseshoe Lake Road
- South along the western side only of Horseshoe Lake Road to Broomfield Terrace
- South along the western side only of Broomfield Terrace to Kingsford Street
- South along the western side only of Kingsford Street to New Brighton Road
- East along the southern side only of New Brighton Road to the western bank of the Ōtākaro / Avon River.
- Following the western bank of the Ōtākaro / Avon River south and west to the Snell Place footbridge
- Due West to the former intersection of Morris Street and Avonside Drive, then West along the northern side only of former Morris Street to the Avon River.
- South along the Western bank of the Ōtākaro / Avon River then south and west to Fitzgerald Avenue
- North along the eastern side only of Fitzgerald Avenue to Bealey Avenue
- West along the northern side only of Bealey Avenue to Packe Street
- North along Packe Street (both sides) to Purchas Street
- West along Purchas Avenue to Madras Street
  - Including addresses on Elderwood Lane

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

## Proposed Special Programme - Te Tāhu Rua Reo (only change – other parts updated for new school name)

The kura/school operates the following special programme; Te Tāhu Rua Reo

The criteria for acceptance into Te Tāhu Rua Reo is as follows:

Respective whānau interested in enrolling will be expected to demonstrate a genuine commitment to te reo Māori, tikanga Māori and te ao Māori. Ākonga will need someone in the home who can understand and speak in te reo and/or currently be committed to learning as a whānau.

Final entry decisions are made by the Senior Leadership Team of Te Oraka in consultation with Ngā Kaiako/Teaching Staff of Te Tāhu Rua Reo.

Te Reo Māori medium provision at Te Oraka has limited space. The number of ākonga/learners able to join Te Tāhu Rua Reo is limited up to 44 places.

For Ākonga who meet the commitment criteria above, priority for acceptance into the programme is in the following order:

1. Ākonga residing within the home zone with siblings currently enrolled in Te Tāhu Rua Reo.
2. Ākonga residing within the home zone.
3. Ākonga residing outside the home zone, who attended a Māori medium pathway at a previous school or who are applying from other Māori Medium providers i.e. Bilingual, Total Immersion, and/or Kura Kaupapa Māori, and Kura Māori.
4. Ākonga residing outside the home zone, with siblings currently enrolled in Te Tāhu Rua Reo.
5. Ākonga residing outside the home zone, whose siblings are former students of Te Tāhu Rua Reo.
6. Ākonga residing outside the home zone, with extended whānau connections to current or former students of Te Tāhu Rua Reo, for example, first cousins.

If there are more applicants in any priority group than places available, a ballot will be conducted. For all other applicants, priority will be given to those where Te Oraka - Te Tāhu Rua Reo is their closest geographical Māori medium provision.

The kura/school will advertise the number of spaces available with their mātua/parents and hāpori/community across their communication platforms.

## Out of Zone Enrolments

Applications for enrolments will be processed in the [following order of priority](#):

1. **First priority** must be given to students who have been accepted for enrolment in the Special Programme (Te Tāhu Rua Reo) run by the school and approved by the Secretary for Education.
2. **Second priority** must be given to any applicant who is the sibling of a current student of the school.
3. **Third priority** must be given to any student who is the sibling of a former student of the school.
4. **Fourth priority** must be given to any applicant who is the child of a former student of the school.

5. **Fifth priority** must be given to any applicant who is a child of an employee of the school's board or a child of a member of the school's board.
6. **Sixth priority** must be given to all other applicants.

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:




- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under [Schedule 20, Clause 3 \(1\)](#) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of address or sibling relationship.

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.
