## TEMUKA PRIMARY SCHOOL (2109) Proposed Enrolment Scheme

## **Home Zone**

All students who live within the home zone described below shall be eligible to enrol at the school.

Note that eligibility to enrol is based on the below written description of the home zone. Any associated maps are a visual representation of this description.

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

From the intersection of Earl Road and Oxford Crossing Road

- East along Oxford Crossing Road to Temuka-Winchester Highway (SH1)
- South along Temuka-Winchester Highway (SH1) to Springfield Road
- East along Springfield Road to Guild Road
- North East along Guild Road to Rise Road
- South East along Rise Road to Milford-Clandeboye Road
- North along Milford-Clandeboye Road to the Orari River
- South East along the southern bank of the Orari River to the coastline
- South West along the coastline, across the Opihi River mouth to Connolly Road
- West along Connolly Road to Waipopo Road
- South West along Waipopo Road to Seadown Road
- South along Seadown Road to Dominion Road East
- West along Dominion Road East to Dominion Road
- West along Dominion Road to Wilson Road
- North along Wilson Road to Arowhenua Road
- West along Arowhenua Road to Roaring Camp Road
- North along Roaring Camp Road to the Opihi River
- West along the northern bank of the Opihi River to Walker Road
- North along Walker Road to Waitohi Temuka Road
- West along Waitohi Temuka Road to Seven Sisters Road
- North along Seven Sisters Road to John Talbot Road
  - Including addresses on Seven Sisters Road from John Talbot Road to Rangatira Valley Road
- South East along John Talbot Road to Waitohi Temuka Road
- East along Waitohi Temuka Road to Earl Road
- North along Earl Road to Oxford Crossing Road

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

## **Special Programmes**

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

## **Out of Zone Enrolments**

Applications for enrolments will be processed in the following order of priority:

- **First priority** is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
- **Second priority** must be given to any applicant who is the sibling of a current student of the school.
- Third priority must be given to any student who is the sibling of a former student of the school.
- **Fourth priority** must be given to any applicant who is the child of a former student of the school.
- **Fifth priority** must be given to any applicant who is a child of an employee of the school's board or a child of a member of the school's board.
- Sixth priority must be given to all other applicants.

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with <u>instructions by the Secretary</u>, under <u>Schedule 20</u>, <u>Clause 3 (1)</u> of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of In Zone address, or proof to support their application if seeking enrolment under the Out of Zone priorities.

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.
