

# TAURANGA INTERMEDIATE (1990)

## ENROLMENT SCHEME

01 JANUARY 2024

The guidelines for the development and operation of enrolment schemes are issued under section 72(1) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

### **Home Zone**

**All students who live within the home zone described below (and shown on the attached map) shall be entitled to enrol at the school.**

*Starting at the mouth of the Kopurererua Stream, as it enters the Waikareao Estuary, the boundary travels east along the shoreline to the rear of 33 Water Lane, which is adjacent to the coast. From here the boundary travels south-east behind (and including) other addresses on Water Lane, and around Te Kura Kaupapa Māori o Otepou on Welcome Bay Road (included in the zone).*

*From here the boundary travels east along Welcome Bay Road, capturing addresses on both sides of this road, to the intersection of Welcome Bay and Rocky Cutting Roads. (Note 879 Welcome Bay Road is excluded from the zone).*

*The boundary travels south, behind (and including) addresses on Rocky Cutting Road to the intersection of Rocky Cutting, Te Puke Quarry, and Kaiate Falls Roads.*

*From this intersection the boundary travels behind (and includes) 176 and 130 Kaiate Falls Road, and then pivots south-east to the northern point of the Ottawa Scenic Reserve.*

*The boundary travels south, along the western boundary of the Ottawa Scenic Reserve, to the south-west corner of the Reserve, then pivots west behind (and including) addresses on Waitao Road and continues to 465 Rowe Road (included in the zone).*

*From 465 Rowe Road the boundary head northward, behind (and including) addresses on Rowe Road, to the intersection of Rowe Road and Upper Ohauti Road.*

*From this intersection the boundary travels north, along the centre of Upper Ohauti Road, to 576 Upper Ohauti Road (included in the zone). Note 590A-D Upper Ohauti Road are excluded from the zone. The boundary pivots west behind (and including) addresses on Neewood Road, continuing to the Waimapu Stream adjacent to the south-west corner of 81 Neewood Road.*

*From here the boundary travels north, along the Waimapu Stream to the rear of 479C Oropi Road. From this address (which is included in the zone) the boundary travels west, behind 505 Oropi Road (included in the zone) and then south along Oropi Road to the intersection with Warner Road.*

*From this intersection the boundary pivots and travels northward behind (and including) even numbered address on Oropi Road and follows the Waiorohi Stream to 91 Joyce Road (included in the zone).*

*From here, the boundary travels west along the centre of Joyce Road, including odd-numbered addresses only, to 225 Pyes Pa Road, which lies at the intersection of Joyce Road and Pyes Pa Road (this address is included in the zone).*

*From 225 Pyes Pa Road, the boundary travels south along the centre of Pyes Pa Road to the intersection with Kennedy Road. From this intersection the boundary travels around (and includes) 2 Kennedy Road, then pivots to travel northward behind (and including) even-numbered addresses on Pyes Pa Road, to the north-west boundary of 202 Pyes Pa Road.*

*From this point the boundary travels north-west behind (and including) addresses on Freeburn Road, Molloy Rise, Bradley Ave, and Jason Place, to 52C Pyes Pa Road (included in the zone). From 52C Pyes Pa Road, the boundary continues north, behind and including 561 and 571 SH29A Pa Road, to SH29A.*

*The boundary then travels west along the centre of SH29A, capturing even-numbered addresses only, to the roundabout with Takitimu Drive (SH36) and Takitimu Drive (SH29).*

*From this round about the boundary travels north, along the centre of Takitimu Drive (SH29) to the point where the Kopurererua Stream crosses this road, then the boundary follows the Kopurererua Stream northward to the mouth as it enters the Waikareao Estuary*

### **Out of Zone Enrolments**

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

### **Special Programmes**

The school does not operate any special programmes

Applications for enrolments will be processed in the following order of priority:

- **First priority** must be given to students who have been accepted for enrolment in the above special programme(s) run by the school and approved by the Secretary for Education.
- **Second priority** must be given to applicants who are siblings of current students.
- **Third priority** must be given to applicants who are siblings of former students.
- **Fourth priority** must be given to any applicant who is a child of a former student of the school.
- **Fifth priority** must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth priority** must be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary under Schedule 20 (2) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.

Proof of residence within the home zone may be required.

### **Transitional Arrangements**

For families of currently enrolled students whose addresses become out of zone as a result of the amendment of this Enrolment Scheme.

**Section 75 of the Education and Training Act 2020** states that,

“The Secretary may authorise an enrolment scheme to permit a student to enrol at the school as if the student lived in the home zone of the school if, -

- (a) in the case of an existing enrolment scheme whose home zone is amended, —
  - (i) the student lives outside the amended home zone; and
  - (ii) the student has a sibling who is enrolled at the school at the time that the amendment is implemented; and
  - (iii) the sibling, at the time that the amendment is implemented, lives inside the home zone as it was before the amendment; and
  - (iv) the student, at the time of enrolment, lives inside the home zone as it was before the amendment:
  
- (b) in the case of a **new enrolment scheme**, the student—
  - (i) lives outside of the home zone of the new enrolment scheme; and
  - (ii) has a sibling who is enrolled at the school at the time that the new enrolment scheme is implemented.

This provision has been approved for inclusion in this Enrolment Scheme for a period of **2 years** from the 1<sup>st</sup> January 2024.

If applying for enrolment under this part of the Enrolment Scheme, the siblings name, and evidence of a sibling relationship may be required by the school.

**Section 75 of the Education and Training Act 2020** sets out the definition of a “sibling” for these purposes.

The school will maintain a list of students enrolled at the time of the implementation of the enrolment scheme and its adoption by the board to enable determination of eligibility to enrol under this provision.
