Upokongaro School (#2469)

Draft Enrolment Scheme Description

The guidelines for development and operation of enrolment schemes are issued under Schedule 20 of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below, and shown on the attached map, shall be entitled to enrol at the school. Both sides of each road are included in the zone unless otherwise stated.

In a clockwise direction:

- 1. The zone starts on Anzac Parade (SH4) at its intersection with the Mateongaonga Stream and travels east on Anzac Parade (SH4) to its intersection with Kaimatira Road.
- 2. At the intersection of Anzac Parade (SH4) and Kaimatira Road, the zone travels south-east on Kaimatira Road to its intersection with Longacre Road, and then returns back along Kaimatira Road to its intersection with Anzac Road (SH4). 124 Kaimatira Road is in zone. No address on Longacre Road are in zone. No addresses on Kaimatira Road east of the intersection with Longacre Road are in zone.
- 3. From the intersection of Kaimatira Road and Anzac Parade (SH4), the zone follows Anzac Parade (SH4) north to the Upokongaro cycle and pedestrian bridge over the Whanganui River. All addresses numbered on Kukuta Road are in zone.
- 4. At the Upokongaro cycle and pedestrian bridge, the zone crosses the river and follows Papaiti Road south to the southern boundary of 169 Papaiti Road. 163 and 163A Papaiti Road are in zone. All addresses numbered on Waireka Road are in zone.
- 5. From the southern boundary of 169 Papaiti Road, the zone travels north on Papaiti Road to northern boundary of 547 Papaiti Road.
- 6. From the northern boundary of 547 Papaiti Road, the zone follows the Whanganui River north to Hipango Park. Only addresses on the eastern side of the river are in zone.
- 7. From Hipango Park, the zone travels north overland, to the settlement of Atene on the Whanganui River Road. All addresses numbered on the Whanganui River Road south of the northern entrance to the Atene Skyline Track are in zone.
- 8. From the settlement of Atene, the zone follows the Whanganui River Road downstream to its intersection with State Highway 4.
- 9. At the intersection of the Whanganui River Road and State Highway 4, the zone travels north on State Highway 4 to the northern boundary of 1365 State Highway 4.
- 10. From the northern boundary of 1365 State Highway 4, the zone returns south along State Highway 4 to the starting point at the intersection of State Highway 4 and the Mateongaonga Stream. All addresses numbered Old Parapara Road are in zone. All addresses numbered on the following no exit roads are in zone: Mangotai Road, Mangaone Road, Matara Road, Kaiwhaiki Road, and Makirikiri Valley Road.

In-Zone Enrolments

Proof of residence within the home zone may be required.

Each year applications for enrolment in the following year from in-zone students will be sought by a date which will be published by notice in a media suitable for the local community. This will enable the school board to assess the number of places which can be made available to students who live outside the home zone. (*This paragraph is optional*)

Out of Zone Enrolments (updated to new Act)

Each year the board will determine the number of places, and the number of pre-enrolment periods, which are likely to be available in the following year for the enrolment of students who live outside the home zone. The school board will publish this information by notice in a media suitable for the school and wider local community. The notice will indicate how applications are to be made, the date by which all applications must be received, and the date any ballot will be held.

Applications for enrolment will be processed in the following order of priority, according to legislation:

First Priority	This priority category is not applicable to this school as it does not operate a special programme approved by the Secretary of Education.
Second Priority	will be given to applicants who are siblings of current students.
Third Priority	will be given to applicants who are siblings of former students.
Fourth Priority	will be given to any applicant who is a child of a former student of the school.
Fifth Priority	will be given to any applicant who is either a child of an employee of the board of the school or a child of a

member of the board of the school.

will be given to all other applicants.

Note: Applicants seeking second, or third priority status, may be required to give proof of a

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under clause 3 schedule 20 of the Education and Training Act 2020.
